I. COMPETITION OVERVIEW

The **LeeAnn Miele Synchronized Skating Open** will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the [current rulebook](#), and/or [current Compete USA handbook](#) as well as any pertinent updates that have been posted on the U.S. Figure Skating [website](#).

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, (if offering Compete USA events) Learn to Skate USA® member, a collegiate club or who is an individual member in accordance with the current rulebook. II. ELIGIBILITY

Synchronized Skating:

- For synchronized skating teams, this competition does **not** require that skating skills test requirements for the team's level be met, except for the maximum allowed at the Compete USA levels (Snowplow Sam Synchro and Aspire levels).

COACHES

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found [in](#) Members Only, click the blue "COACH" button.

All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

Credentials will be issued to two coaches per registered team.

TEAM SERVICE PERSONNEL

Teams are permitted a maximum of two team service personnel. Team service personnel must have a current U.S. Figure Skating or Learn to Skate USA® membership, a green lighted background check and completed SafeSport™ Training. All compliance requirements must be met at the time of check-in to access the competition, no exceptions. Team service personnel is defined as those indicated as a team manager and/or team service personnel planning to attend the competition with the team.

MANDATORY

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training. *

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. MUSIC AND PLANNED PROGRAM CONTENT (PPC-for IJS teams only):

Music for all teams and the PPC for IJS teams must be uploaded to EntryEeze. Directions for uploading will be posted on the EntryEeze site.

Teams must also have available a backup copy of their competition music on a cell phone and it must be immediately available rinkside whenever the team competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

The deadline for uploading Music and the PPC (for IJS teams only) is October 26, 2025, at 11:59 p.m. A late fee of \$25.00 will be assessed for each component that is uploaded after the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving team credentials onsite.

REFUND POLICY

Entry fees will not be refunded after entry deadline unless no competition exists or the event is canceled. There will be no refunds for medical withdrawals. Credit card fees are not refundable.

IV. COMPETITION DETAILS

FACILITIES:

Schneider Arena, Providence College

Rink size: 200' x 85' This arena has a very comfortable temperature. The snack bar at the rink will not be open. Please check our website for updates as we get closer to the competition date. There are many restaurants in the area.

PARKING INFORMATION: Schneider Arena is located at the corner of Admiral Street and Huxley Avenue. Street parking is sometimes available on Huxley Avenue, but that is not guaranteed. For another parking option, drive on Huxley Avenue past Schneider Arena until you reach the security gate. Tell the guard that you are going to Schneider Arena. You will be directed to the parking garage, which is close to the Schneider entrance. Depending on campus activities on the day of the competition, the security guard may direct you to a parking area other than the garage.

Regardless of where you park your car, you should proceed to the entrance for Schneider Arena that is near the parking garage. This is the location for skater check-in and the spectator entrance to the ice.

IMPORTANT! If using GPS, do **NOT** use the main address for Providence College; you will end up on the opposite side of the campus. Use the address of Schneider Arena, 331 Huxley Avenue, Providence, RI.

There is no charge for parking in the garage.

Admission to the competition will be charged. Details will be available on our website at a later date.

Team Locker Rooms:

The designated team coach, team manager, team service personnel and athletes competing at the skating event are allowed in the Locker Rooms/Changing Area designated for their team. The team coach, team manager, and team service personnel must remove themselves from the Locker Room/Changing Area while any Minor Athlete(s) are actively changing or undressing. All Locker Rooms/Changing Areas will be monitored. If any concerns arise, immediately contact the Locker Room/Changing Area monitor. If there are concerns regarding this policy, an athlete should change prior to arriving at the competition. The use of any recording and photographic devices inside a Locker Room/Changing Area is strictly prohibited. Any violation of this policy is punishable under the U.S. Figure Skating SkateSafe® policy and U.S. Figure Skating Rulebook.

U.S. Figure Skating Travel Policy:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors who are at least 8 years of age or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). OFFICIAL WEBSITE & UPDATES:

The official event website is ppfsc.org. PPFSC will post updates and announcements on the club website and email, as appropriate. It is the responsibility of each competitor, parent and coach to check the website and email frequently for any schedule changes and/or additional information pertaining to the competition.

Teams may be scheduled to compete at any time during the announced date of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available.

UNOFFICIAL PRACTICE ICE (UPI):

Unofficial practice ice will be available for purchase online during the registration process. Each team will be able to purchase only one practice session during this period. Please refer to the following list for the durations and costs of practice ice sessions. Once entries have closed, any remaining practice ice sessions will be available for purchase; all registered teams will be notified of any available sessions.

- Practice ice will be scheduled at various times on the day of the competition.
- Practice ice fees will not be refunded after entry deadline unless no competition exists or the event is canceled.

Music will be played during a team's practice session.

Music for all teams and the PPC for IJS teams must be uploaded to EntryEeze. Directions for uploading will be posted on the EntryEeze site.

ONSITE CHECK-IN:

Check-in will open on Sunday, November 9, 2025 at 7:00 a.m. and will be located in the Schneider Arena Lobby, located at the entrance closest to the parking garage.

AWARDS:

For Aspire 1-4 events: There will be no more than six competitors in a group, and all six will receive an award.

For all other events: Medals will be awarded to all skaters for first, second, third, and fourth place.
