Please note that USFS has increased its fees for the upcoming year. The increased fees apply to both individuals and member clubs. We have passed these increases onto the fees we are charging for this year. In addition, we have made additional adjustments in the fees charged in some categories to better meet the needs of our members with respect to purchasing ice and / or volunteering.

We remind all Club members that a current membership is necessary in order for any skater to be able to skate on a Club ice session, participate in a team activity, test and / or compete. Please note that your membership will not be processed until it is received by the Membership Chair.

(1) PPFSC membership details:

- These membership categories apply to those having PPFSC as their home club.
- They include a membership with USFS.
- With the exception of a Subsequent Membership, they include a subscription to SKATING magazine.
- Skaters represent PPFSC at all competitions, test sessions, and shows.
- All PPFSC members will receive USFS certificates for tests passed.

(2) Types of USFS memberships:

- First family membership
- Subsequent membership- for an additional member from the same family
- Introductory membership- available for a one-time reduced fee, can only be used by new members during their first year of a FULL membership (not Learn to Skate) with USFS
- Collegiate membership- four years of membership in USFS & PPFSC
 - skater must be in college (any year), or entering this fall, either graduate or undergraduate
 - o membership good for 4 years
 - o may be used only once
 - o additional family members pay the Subsequent member fee
- (3) Fees reflect the amount due based on the postmark. Ex.: \$115 / \$125 means that the membership fee is \$115 if postmarked by June 25; the fee is \$125 if postmarked June 26 or later.

(4) Additional details

- Coaches in the Friend membership category will owe volunteer service hours as defined in their pro contract.
- "PPFSC ice* refers to ice time that is operated by PPFSC at Schneider Arena and other locations as listed in the relevant ice application. Please contact a club official if you are not sure.
- Members who are in the Gold membership category and are contracting ice have a volunteer service requirement as defined in the ice contract.

- <u>Walk-on passes for Gold membership category</u>: The option to purchase a packet of walk-on passes utilizes \$25 as the cost of a single pass.
 - \$300 in ice time in passes includes 12 passes;
 \$150 in passes includes 6 passes
 - These passes may be used at any PPFSC session from July 1, 2025-June 30, 2026.
- Members who are in either the Gold or Silver membership category and do not fulfill the requirements will have their membership converted to a Bronze category and will be charged the prorated Bronze membership fee.

Introductory Silver First family member	\$105/ 115	Description is the same for Silver first Family member. Only the fee is different Volunteer for 4 hours during November 8-9 (LeeAnn Miele Synchro Comptition).
Bronze First family member	\$340 /350	No requirement to purchase ice or volunteer.
Bronze Subsequent	\$160 / 170	No requirement to purchase ice or volunteer.
Introductory Bronze First Family member	\$145 / 155	No requirement to purchase ice or volunteer.

U.S. Figure Skating Member Code of Conduct GR 1.02

1.02 Code of Conduct The following code of conduct applies to all participants in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating including but not limited to competitions, exhibitions and training camps:

I recognize that my participation in all activities hosted, supported, sponsored or engaged in by U.S. Figure Skating, including but not limited to competitions, exhibitions and training camps, is an honor and privilege that carries certain responsibilities. I agree to fully abide by the rules and guidelines set forth by U.S. Figure Skating or its properly designated agents. As a precondition to participation in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating, I will adhere to the following tenets in good faith:

- A. I will exhibit the highest standards of fairness, ethical behavior and genuine good sportsmanship in all of my relations with others. B. I will not discriminate against any member or participant on the basis of race, color, religion, age, gender, gender identity, sexual orientation, national origin, or any other status protected by federal, state or local law, where applicable.
- B. I will not damage public or private property. I understand that I may be held financially responsible for damage deemed to be wantonly or willfully executed on my part, and that I may be subject to disciplinary action by U.S. Figure Skating.
- C. I will not use or possess illegal drugs, and I will not engage in criminal activity. I understand that, if I am found to use or possess illegal drugs, or if I am found to engage in any criminal activity during any activity hosted, supported, sponsored or engaged in by U.S. Figure Skating, I may be subject to criminal penalties as well as penalties imposed by U.S. Figure Skating.
- D. I will adhere to the rules of U.S. Figure Skating and the host organization at all activities hosted, supported, sponsored or engaged in by U.S. Figure Skating.

- E. I will comply with all applicable anti-doping rules including, but not limited to, ISU anti-doping rules.
- F. I will conduct myself in a manner not detrimental to the welfare of figure skating. I understand that my actions reflect on U.S. Figure Skating and the sport of figure skating both positively and negatively. I understand that if my acts, statements, or conduct are considered detrimental to the welfare of figure skating by the appropriate authority, I may be subject to penalties imposed by U.S. Figure Skating pursuant to GR 1.04.
- G. I understand that the penalties that may be imposed may include, but are not limited to, loss of future international selections, loss of financial support from U.S. Figure Skating and its Memorial Fund, and loss of participation in activities hosted, supported, sponsored or engaged in by U.S. Figure Skating.
- H. I understand that all disciplinary proceedings will be conducted pursuant to Article XXV, Section 3, of the U.S. Figure Skating bylaws, and that my rights and remedies are derived therefrom.
